BENEFIT CHANGES

Shingrix Vaccination coverage began on June 18, 2026. Vaccines covered up to \$1000 at 80%. A perscription is needed. There is no age restriction.

New Dental Fees have been implemented on June 23, 2026

The new STDP program has not begun yet. The Government has 90 days to present their proposal to Service Canada. We are not sure when these changes will be implemented.

Social Worker and Psychotherapist coverage began on July 9, 2026. The maximum is \$3000 per Calendar year.

Massage Therapy coverage has increased to \$500 at 80% on July 9, 2026.
